 - \$400,000.00 still remaining in budget due to later fire season, reduction in staffing and management of un-planned overtime

 - Section I, part C, number 5 of Proposed Ordinance
 - <u>Motion</u>: made by John Willett to change number 5, to "Recognized labor organization representing career fire fighters providing service for County Fire." <u>Motion seconded by</u>: Mike Coryell <u>In Favor</u>: Kathleen Lineberry, Nancy Carr-Gordon, Donita Springmeyer, Alex Leman and Arnie Wernick
 - Motion passed unanimously
 - No changes made to parts A & B of Section II of Proposed Ordinance
 - Section II, part C of Proposed Ordinance

 - Motion passed unanimously

- Section III, part A, number 5 of Proposed Ordinance
 - <u>Motion</u>: made by Nancy Carr-Gordon to change number 5, to "Such other matters relating to the county's fire protection, rescue, and emergency medical services program as the Commission desires to bring to the attention of the board of supervisors."

6.1 Fire Chief (Chief Ferreira)

- 6.1.1 Update on recent fire activity
 - Summit Fire Huge response from all agencies involved in and Santa Clara is investigating the cause of the fire. Good success no injuries.
 - Zayante Fire Good response
 - Bonny Doon Fire Huge response, technical difficulties early on. Lots of community meetings, good response by local volunteer company. Sheriff's office did good job with evacuations and animal evacuations.
 - Trabing Fire 26 houses and outbuildings lost. More organized and were able to move quicker with this fire.

- 6.1.2 Update on public information work with Planning, Environmental Health, and Natural Resource Conservation District
 - Good time to get cooperation from other agencies within the county. Natural Resource Conservation District has grant money and has started working on grant ideas.

 - Presently at 5 engines total, staffing some county engines, 9 engines are out. 4 person staffing on the five engines.
