APPROPRIATION OF 2010 HOMELAND SECURITY GRANT FUNDS

Dear Members of the Board:

Since 2001, the California Emergency Management Agency (CalEMA) has been providing local jurisdictions with Homeland Security Grant funds for costs associated with emergency planning activities, emergency response training, and communications infrastructure. The County of Santa Cruz Office of Emergency Services (OES) is responsible for administering and managing the grant locally.

Unanticipated revenue from the 2010 Homeland Security Grant was previously approved for County Fire on October 16, 2012, Item #19. We are please to inform your Board that County Fire has been notified by Cal EMA of its eligibility to use an additional \$5,199 in 2010 re-allocated funds. The Office of Emergency Services has approved the use of this funding for County Fire to purchase rescue rope to be utilized in large area search and rescue in Santa Cruz County. This would aid in emergency response conducted by County Fire personnel as well as local public safety agencies.

It is therefore RECOMMENDED that your Board adopt a resolution accepting and appropriating unanticipated 2010 Homeland Security Grant Funds in the amount of \$5,199 and approve the purchase of large area rescue rope.


