B. Draft Proposed 2013-14 Budget

- 1) Increased benefit rate of 3%, decrease of .02% admin fee, removal of .33 Fire Marshal position in the Cal Fire contract.
- 2) Increased expenditures due to necessary mobile equipment purchases.
- 3) Increases to County charges and one time Planning Dept. contribution added for Street Addressing clerk position.
- 4) CSA fees will increase by 2012 CPI of 2.7%.
- 5) The Budget Subcommittee will work on scheduling a time to meet in mid-April.

C. Fire Engine Purchase Discussion

- 1) Chief Larkin has made an offer for the used Felton FPD engine. No reply yet. This equipment purchase would be considered a stop-gap measure. Cost could be somewhat offset by the reserve engine rental to Morgan Hill Fire Dept.
- 2) Due to the imminent need for replacement engines, the commission will continue to work on drafting a recommendation letter for a bond proposal.
- 3) Discussed the need for a Mobile Equipment Subcommittee.

- 6.1 Santa Cruz County Fire Chief's Report
