Thank you for sending these minutes out, Ginny. These minutes make no mention of the three members of the public that were present or of any public input on discussion. Shouldn't that be included? Also, Chief Hess did not give a report and was not present.

I really would like the minutes to reflect my protest in the Measure G deceptive wording regarding the sales tax funding County Fire Budget and possible impacts on passage of a CSA 48 increase in the spring. I would also like to include in the minutes our discussion regarding Prop. 172 money as a matching amount for a possible CSA 48 increase request from the property owners.
